**ORDER**

Sub: Debarment of Shri Priya Ranjan Parhi, IRTS (1997) from deputation under Central Staffing Scheme.

Orders contained in Department of Personnel & Training's O.M. No 83/1/2022-EO(CVO) dated 24.03.2022 regarding deputation of Shri Priya Ranjan Parhi, IRTS (DOB: 14.10.1968; DITS: 04.09.1997), ED/Infra-I, Railway Board to National Highway Authority of India (NHAI), Delhi under the Ministry of Road Transport & Highways for the post of Chief Vigilance Officer may be treated as cancelled.

2. Competent Authority has decided that Shri Priya Ranjan Parhi, IRTS, stands debarred from all kinds of central deputation (including Central Staffing Scheme) for a period of five years w.e.f. 24.03.2022. In addition, officer is also debarred from being given cadre clearance for any foreign assignment/consultancies abroad, during the period of debarment as per the extant policy.
