Sub:- Deputation of Shri HUBLAL JAGAN (IRPS, DOB:12/11/1966), formerly Professor (Personnel Management), NAIR to National Rail and Transport Institute (NRTI).


The post-facto sanction of the Competent Authority is hereby communicated to the deputation of Shri HUBLAL JAGAN, IRPS, NAIR to NRTI as Dy.Comptroller/HR on the following terms & conditions:-

- I. Period: From 21.08.2019 to 20.08.2022 or until further orders, whichever is earlier.
- II. Pay & Allowances: The officer will draw pay which would have been admissible to him from time to time on the Railways plus deputation (duty) allowance in terms of the Ministry of Personnel, PG & Pensions (Deptt. of Personnel & Training)'s O.M No. 06/08/2009-Estt.(Pay-II)dated 17/06/2010 and No.2/11/2017-Estt.(Pay-II) dated 24/11/2017 and 15/03/2021circulated under Railway Board's letter No. 2010/F(E)II/I(I)/I dated 28/07/2010 and No.F(E)II/2017/DE/1/2 dated 26/12/2017 and 17/01/2022, respectively.

Note:- Pay for this purpose does not include special pay, if any, drawn on the Railways. Also, 'if any deviation will be there as and when RRs are notified, the said tenure of Sh. Hubal would be governed in terms of RRs only as has been stated by DOP&T that 'a post is required to be filled up strictly as per the provisions contained in the notified RRs'.

2. The other terms and conditions will be as shown in the Annexure.
3. For the purpose of item IV (Travelling Allowance), for item V (Medical Facilities), item VII (Leave & retirement benefits) and item VIII (Group Insurance Scheme) of the annexure, Pr.FA, Western Railway, Mumbai, will be the concerned officer.
4. This issues with the vetting of the Finance Directorate of the Ministry of Railways.
