No. 06/08/2009-Estt.(Pay-II) dated 17/06/2010 and No. 2/11/2017-Estt.(Pay-II) dated 24/11/2017 & 15/03/2021 circulated under Railway Board's letter No. 2010/F(E)II/I(I)/I dated 28/07/2010 and No.F(E)II/2017/DE/1/2 dated 26.12.2017 & 17.01.2022 respectively.

Note:- Pay for this purpose does not include special pay, if any, drawn on the Railways.

2. The other terms and conditions will be as shown in the Annexure.
3. For the purpose of item IV (Travelling Allowance), item VII (Leave & retirement benefits) and item VIII (Group Insurance Scheme) of the annexure, PFA, Central Railway, Mumbai, will be the concerned officer and for item V (Medical Facilities), PFA, Northern Railway, New Delhi will be the concerned officer.
